<b>Position Title:</b>	Researcher (two positions)
<b>Classification:</b>	HEW Level 4 (casual)
<b>Duration:</b>	Part-time (up to 15 hours per week) for five weeks (January 11 – February 11)

### DUTY STATEMENT

#### Primary Purpose of Position

The purpose of these roles is to work as part of the production team on an upcoming Q&A style program on the topic of freedom of speech in a digital age. This project is a collaboration between The University of Queensland and the ABC, and will be recorded on campus on February 11, 2020.

Under the supervision of the ABC's Executive Producer, Associate Producer and Production Manager, the researchers will source contributors, write briefing notes and assist with other aspects of production as required.

Researchers will be based in UQ's Department of Communication and Arts.

#### Duties

Duties and responsibilities include, but are not limited to:

- Work with the production team to choose and research the broad issues to be discussed in the program
- Write briefing papers for the presenter and executive producer
- Liaise with guest panellists and selected audience members
- Conduct pre-interviews and write briefings on the panellists and key audience members
- Participate in discussions about the program structure
- Draft a program structure and questions
- Research and produce 'set-up' packages to play during the production, that will outline the main issues and set the tone for the rest of the discussion.
- Research and plan graphics for use at key points in the program.

Position reports to the Prof Peter Greste.
